
Madam/Sir,

In inviting a reference to F.D. letter on the subject cited above, I am to say that the deadline for surrender of unutilized funds in respect of budgetary provision for 2009-10 was fixed as 20.02.2010. Due to non-receipt of the surrender statements, compilation of the same in FD and reconciliation in A.G's office have been badly delayed. A.G. (A & E), Orissa is pressing hard for submission of the surrender statements and re-appropriation orders including those based on Supplementary statement of expenditure 2009-10. It is therefore, necessary that the Administrative Department should ensure submission/proper accounting of all re-appropriation orders including those based on Supplementary statement of expenditure and surrender statements for 2009-10, immediately.

I, therefore, request you to look into the matter personally and ensure submission/proper accounting of re-appropriation orders in the Office of A.G.(A&E), Orissa, immediately. Surrender statements for 2009-10, if not submitted, should be submitted to Finance Department immediately for resumption of savings and onward transmission to the office of the AG (A & E), Orissa.

This may be treated as **MOST URGENT**.
