Sub: Clarification regarding delegation of powers and modification of procedures for sanction of State Jailed Freedom Fighters' Family Pension.

Delegation of powers for sanction of State Jailed Freedom Fighters Family Pension to the Pension Disbursing Authority was made vide Finance Department Resolution No.466/F dt. 4.1.2010. Doubts have been raised in certain quarters regarding disposal of pending cases as on 4.1.10 for sanction and payment of State Jailed Freedom Fighters Family Pension. After careful consideration Government have been pleased to clarify that the pending cases for sanction and payment of State Jailed Freedom Fighters Family Pension where payment of pension has been ceased before 4.1.10 shall be disposed of by the Pension Disbursing Authority as per the Delegation of powers issued vide Finance Department Resolution No.466/F. dt. 4.1.2010, subject to submission of requisite documents by the eligible legal heir of the deceased freedom fighter as enumerated in the said Resolution and verification of the same by the concerned Pension Disbursing Authority.

It is further clarified that authorised Public Sector Banks being the Pension Disbursing Authority are competent to sanction and disburse the State Jailed Freedom Fighters' Family Pension as per the delegation of powers made in the said Resolution observing due formalities.


The Pension Disbursing Authority shall keep the Principal Accountant General (A & E), Orissa, Bhubaneswar informed about the fact of sanction of family pension.






