Sub: **Simplification of the Scheme on 'Revised Pension Disbursement Procedure' for payment of Pension in Treasuries through the Bank Account of the pensioner.**

In terms of Paragraph 3.3 of the Scheme on "Revised Pension Disbursement Procedure" appended in Finance Department Office Memorandum No.26708/F dated 10.6.2011 , for payment of pension in the Treasuries through the Bank account of the pensioners, the pensioners are required <sup>to</sup> appear before the Treasury Officer for personal identification in the month of April and November each year.

2. For the sake of convenience of the pensioners and in keeping with similar dispensation for the Central Government civil pensioners drawing pension through Public Sector Banks (Paragraph 15.1 of the Scheme for payment of pension to Central Government Civil Pensioners through Authorized Banks) the aforesaid provision of the scheme "Revised Pension Disbursement Procedure ", is modified so as to allow the State Government pensioners to appear before Treasury Officer once a year in the month of November who will sign the Life Certificate prescribed in Annexure-V of the aforesaid scheme.

3. Accordingly Paragraph 3.3 of the scheme on "Revised Pension Disbursement Procedure" stands revised as follows:


Pensioners drawing pension through the revised pension procedure shall appear before the Treasury Officer for personal identification once a year in the month of November. The pensioner will also furnish non-employment / non-marriage / re-marriage declaration to the Treasury Officer as per S.R.301, 302 & 303 of the Treasury Code.
