Sub: Upgradation of the posts in Odisha Finance Service.

The matter of streamlining the OFS cadre structure was under active consideration of the Government for some time to avoid stagnation in promotion and the resultant erosion of productivity in the cadre. Government have been pleased to restructure the cadre strength of the Odisha Finance Service by way of upgradation of posts in different cadre.

Accordingly, 3 (three) posts of Accounts Member, Odisha Sales Tax Tribunal are upgraded to OFS (Special Secretary Grade) and 8 (eight) posts of FA-cum-Joint Secretary to Government in different Departments are upgraded to OFS (Superior Administrative Grade) and 18 (eighteen) posts in OFS-I(SB) grade have been upgraded to OFS (Supertime Grade) (details will be notified separately).

2. Now, after upgradation, the cadre strength of the Odisha Finance Service is as follows:
