Sub: - Revision of conveyance allowance for blind and physically handicapped State Government employees.

The conveyance allowance payable to the Blind and Physically handicapped persons serving under the State Government was revised at a flat rate of ₹ 150/- per month In Finance Department Office Memorandum No.8145-CSII-45/98-F dated the 5th March 1999. Revision of the rate of conveyance allowance was under consideration of Government for some time past. After careful consideration, the State Government have now decided to revise the existing rate of conveyance allowance for Blind and physically handicapped State Government employees to a flat rate of ₹350/- (Rupees three hundred and fifty only) per month effective from the 1st April 2013.

2. All other terms and conditions as laid down in F.D.O.M.NO.8145-CS-II-45/98-Fdt-5.3.1999 remain unaltered.
