Sub:- Sanction of Dearness Allowance @11% from existing rate 212% to 223% w.e.f. 01.01.2015 in favour of State Government Employees drawing their pay in pre-revised Scales of Pay.

State Government have earlier sanctioned D.A.@ 12% in favour of State Government Employees raising from 200% to 212% w.e.f. 01.07.2014 drawing their pay in pre-revised Scale vide F.D.O.M.No.29187/F,dt.15.10.2014.

- 2) Thereafter, additional dose of D.A.@ 6% was sanctioned in favour of State Government employees in the revised scales of pay w.e.f. 01.01.2015 raisingfrom107 % to 113% in F.D. O.M. No-12410/F., dt.20.04.2015.
- 3) In the meantime Government of India have sanctioned additional dose of <u>D.A.@11%</u> raising from <u>212%</u> to <u>223</u> w.e.f. <u>01.01.2015</u> vide their <u>O.M.No-1(3)/2008-E.II(B).</u>, dtd. <u>24.04.2015</u> in respect of Central Government employees who continue to draw their pay in the pre-revised Scales of Pay.
- 4) Now taking in to account, the overall financial resources and fiscal targets stipulated under Odisha Fiscal Responsibility and Budget Management Act, 2005, the State Government have been pleased to release additional dose of DA @11% enhancing the same from the existing rate of 212% to 223% on the Basic Pay and Grade Pay taken together
- 5) The manner of payment to the State Government employees as outlined in para-4 above is also applicable to the following categories of employees.
- (i) The teaching and non-teaching staff of Universities who are in receipt of regular scale of pay for whom the State Government is bearing full salary cost. These also include Teachers of Universities who enjoy AICTE/UGC scale under ORSP (College Teachers) 2001 and Medical College Teachers under ORSP (Medical College Teachers) Rules, 2001;
- (ii) Subordinate Judicial Officers drawing their pay in accordance with Law Department Resolution No.23598/F., dated 03.06.2003;
- (iii) Work-Charged employees drawing pay in regular scale of pay under the ORSP Rules 1998.
- (iii) Job Contract Workers of Consolidation and Settlement Organisation who are in receipt of fixed pay in regular scale of pay and DA sanctioned thereon from time to time.

- 5. DA in accordance with this Memorandum will also be admissible to the State Government employees who were in service on the **1**st **January**, **2015** but have ceased to be in service at the time of sanction of this enhanced DA.
- 6. The bill for drawal of enhanced DA @11% w.e.f. 01.01.2015 to the State Government employees and employees of Aided Educational Institutions, those are in prerevised scales of Pay will be submitted to the Treasuries/Special Treasuries/Sub-Treasuries along with the Pay Bill for the month of May, 2015 payable in June, 2015 onwards.
