## OFFICE MEMORANDUM

Sub: Implementation of Audit Tracking System through Odisha Central Audit Management Portal in all Departments of Government.

Implementation of Audit Tracking System through Odisha Central Audit Management Portal is introduced vide F.D. Office Memorandum No.14121 dt.29.04.2014. This is an IT Based Audit Management System to facilitate Departments of Government of Odisha to monitor and to take timely action on Audit Observations and Public Accounts Committee Recommendations. Initially as per the implementation strategy two Departments of Government i.e. Panchayati Raj Department and Finance Department have started the Pilot Programme. In the mean while the Inspection Reports and Draft Audit Paragraph are being uploaded to the software by the A.G. Authorities and compliance have been submitted through the software.

To make the system more effective and workable, it is necessary to implement it for all Departments of Government, so that henceforth, all the Inspection Reports, Draft Audit Paragraphs, Draft Audit Notes will be uploaded in the software and to be transmitted to the concerned authorities for compliance through the system based methodology.

All the Departments of Government are therefore, requested to identify trainers to be trained for implementation of the programme in the Department. Training will be given to the trainers in phased manner at headquarter level with the help of OMEGA Technical Assistance Support Team and the trainers of the Departments will impart training to the field functionaries.

After careful consideration, it is decided that the Audit Tracking System through Odisha Central Audit Management Portal will be implemented in all Departments of Government From 14<sup>th</sup> July, 2014.
