

Sub: Submission of Memorandum to State Finance Commission.

Madam/Sir,

You are aware that under Article 243 – (1) of the Constitution of India the Governor of Odisha has constituted the 4th State Finance Commission and the Commission is now functioning inside the Odisha Secretariat in the Annexe Building of Finance Department. The Commission has been given the mandate to make recommendations on the following points after taking into consideration the revenue proceeds of the State Government and the demands thereon on account of expenditure of civil, administrative, police and judicial administration, education, maintenance of capital assets, social welfare, debts and receipts and other committed expenditure and liabilities, in addition to the liabilities of Panchayati Raj institutions and municipalities in respect of discharging and implementing the schemes entrusted to them under article 243 – (G) and 243 - (W) of the Constitution.

- (i) (a) The Distribution between State and Panchayati Raj institutions and the municipalities of the net proceeds of taxes, duties, tolls and fees leviable by the State which may be divided amongst them under Part-IX and Part-IXA of the Constitution and the allocation between the Panchayats at all levels and the Municipalities of their respective shares of such proceeds.
 - (b) the determination of taxes, duties, tolls and fees which may be assigned to or appropriated by Gram Panchayats, Panchayat Samities and Zilla Parishads or, as the case may be, Municipalities, and
 - (c) the grants-in-aid to the Grama Panchayats, Panchayat Samities, and Zilla Parishads or, as the case may be, Municipalities from the Consolidated Fund of the State:
- (ii) The measures needed to improve the financial position of the Gram Panchayats, Panchayat Samities, Zilla Parishads and Municipalities.
- (iii) Or any other matter, which the Governor may refer to the Commission in the interest of sound finance of Gram Panchayats, Panchayat Samities, Zilla Parishads and Municipalities.

Since the Commission is required to submit its report within the shortest possible time I would request you to kindly arrange and submit detailed memorandum to the Commission containing your suggestions on the existing functioning of Panchayati Raj institutions, present devolution of functions and funds, other obligatory functions, the Zilla Parishad is required to discharge and with suggestion and the manner of resource mobilisation to strengthen the financial condition of the Panchayati Raj institutions and Urban Local Bodies by 10.12.2013.

You are aware that under Article 243(I) of the constitution of India the Governor of Odisha has constituted the 4th State Finance Commission and the commission is now functioning inside the Odisha Secretariat in the annex building of Finance Department. The Commission has been given the mandate to recommend principles as mentioned below after taking into consideration the revenue proceeds of the State Government and the demands thereon on account of expenditure of civil, administrative, police and judicial administration, education, maintenance of capital assets, social welfare, debts and receipts and other committed expenditure and liabilities, in addition to the liabilities of Panchayati Raj Institutions and Municipalities in respect of discharging and implementing the schemes entrusted to them under the article 243(G) and 243(W) of the constitution.

- (i) (a) the distribution between State and Panchayati Raj Institutions and the Municipalities of the net proceeds of taxes, duties, tolls and fees leviable by the State which may be divided amongst them under Part-IX and Part-IXA of the Constitution and the allocation between the Panchayats at all levels and the Municipalities of their respective shares of such proceeds.
 - (b) the determination of taxes, duties tolls and fees which may be assigned to, or appropriated by Gram Panchayats, Panchayat Samities and Zilla Parishads or, as the case may be Municipalities, and
 - (c) the grants-in-aid to the Gram Panchayats, Panchayat Samities, Zills Parishads or, as the case may be Municipalities from the Consolidated Fund of the State;
- (ii) The measures needed to improve the financial of the Gram Panchayats, Panchayat Samities, Zilla Parishads and Municipalities.
- (iii) Or any other matter, which the Governor may refer to the Commission in the interest of sound finance of Grama Panchayats, Panchayat Samities, Zilla Parishads and Municipalities.

Since the report is to be submitted within a very short time, the Commission appeals for your views and suggestions on present functioning of Panchayati Raj Institutions and Urban Local Bodies, strengthening its resources base and improvement in system for discharging the obligatory functions etc. which would be beneficial to the Commission to formulate the principles for devolution of funds to above bodies and for development of working of Rural Local Bodies and Urban Local Bodies at their different tiers.
