

## SPECIAL SUPPLEMENT To BUDGET, 2019-20 For Panchayati Raj Institutions(PRIs)

FINANCE DEPARTMENT July, 2019

## PREFACE

The 4<sup>th</sup> State Finance Commission constituted under the provisions of Article-243-I and 243-Y of the Constitution of India, read with Section 3 and 8 of the Odisha Finance Commission (Miscellaneous Provisions) Act, 1993 (Odisha Act 28 of 1993) has submitted its report to the Hon'ble Governor of Odisha in September, 2014 covering all aspects of its mandate. In its recommendations, the Commission has addressed the issue of transfer of resources to the Local Bodies of the State out of the State's Taxes and Consolidated Fund. The Commission has also emphasized on strengthening resource base of the Local Bodies to help them to evolve into responsible units of Local Self-Governance.

- (i) Devolution: The Commission in its report recommended inter-sedistribution of Devolution amongst the three tiers of Panchayati Raj Institutions. The recommendations are based on population as per 1991 census and have stipulated devolution amongst the Gram Panchayats, Panchayat Samities and Zilla Parishads of the State.
- (ii) Assignment of Taxes: The Commission has recommended transfer of fund out of Entry Tax for salary and establishment requirements, payment of Honorarium, sitting Fees, T.A and D.A of the elected representatives of Panchayati Raj Institutions. Similarly funds out of Motor Vehicle Tax are earmarked for maintenance / improvement of road infrastructure.
- (iii) Grants-in-Aids: Similarly, the Commission has identified some specific services and infrastructure needs of Panchayati Raj Institutions in its report and has recommended Grants-in-Aid to meet the fund requirement for these focus areas in addition to the funds provided under Devolution and Assignment of Taxes. Some of these key areas are Water Supply, Street Light, Staff Quarters (GP), Staff Quarter (Panchayat Samities), Maintenance of Capital Assets, Creation of Capital Assets for Revenue Generation and Incentive.

As per the decision taken at point 5.8 of the Action Taken Report on the recommendations of the 4<sup>th</sup> State Finance Commission, a Special Supplement to the Budget document in respect of transfer of fund to Local Bodies on the basis of the recommendations of the Commission is to be presented by the Finance Department in the Legislative Assembly by the end of fiscal year regarding utilisation of grants by the Local Bodies.

The Supplement for Rural Local Bodies (Panchayati Raj Institutions) for the 4th fiscal year of the 4th SFC award period i.e. year ending by March 2019 has been prepared in compliance to the above decision of Government in the Action Taken Report. The Supplement provides information on Actuals for 2015-16, 2016-17, 2017-18, Revised Estimates for the year 2018-19 and Budget estimates for the year 2019-20.

The Supplement captures the Functional Major Head/Minor Head-wise provision upto Object Head earmarked for transfer to all the three tiers of Rural Local Bodies.
