RESOLUTION


Sub: Revision of rates of State Freedom Fighters' Pension.

The enhancement of the existing rates of Freedom Fighters' Pension was under consideration of Government for some time past. After careful consideration, Government have been pleased to decide as follows:-

- i) The existing rate of State Token Freedom Fighters' Pension for the Freedom Fighters and their eligible dependants who are in receipt of Swatantrata Sainik Samman Pension from Central Revenue, shall be enhanced from Rs.4000/- to Rs.8000/- per month w.e.f. 1st day of April, 2017.
- ii) The existing rate of Pension for the State Freedom Fighters and their eligible dependants who are in receipt of only State Freedom Fighters' Pension (Jailed) under previous Scheme of State Government i.e. prior to 2002 shall be enhanced from Rs.6000/- to Rs.10,000/- per month w.e.f. 1st day of April, 2017.
- iii) The existing rate of State Freedom Fighters' Pension (Non-Jailed) under the new Scheme, 2002 and Goa Liberation Movement Scheme, 2004 shall be enhanced from Rs.5000/- to Rs.9000/- per month w.e.f. 1st day of April, 2017.
