Sub: Sanction of Dearness Allowance to the Work Charged employees covered under ORSP Rules, 2017 with effect from 01.01.2016, 01.07.2016, 01.01.2017 & 01.07.2017 on the Revised Scales of Pay, 2017.

The State Government have been pleased to release two doses of D.A to regular State Government employees i.e. @2% w.e.f. 01.07.2016 and @2% w.e.f. 01.01.2017 vide F.D.O.M No.30656/F,dt.23.10.2017 as mentioned in Table-1 below.

2. It has been stipulated in the aforesaid Office Memorandum that consequent upon revision of the scales of pay with effect from 01.01.2016 in case of State Government employees followed by sanction of the revised dose of D.A. as indicated in Table -1, the Dearness Allowances sanctioned, vide F.D.O.M No.13362/F, dt.30.04.2016 and F.D.O.M No.34154/F, dt.19.12.2016 stand adjusted with the emoluments in the revised scale. As such, the payment of DA from the dates mentioned in the Table-1 above shall be made after adjusting the installment of Dearness Allowance sanctioned and paid to the State Government employees as indicated in Table-2.

3. Further, additional dose of D.A. @1% w.e.f 01.07.2017 enhancing the existing rate from 4% to 5% has been released in favour of State Government employees vide F.D.O.M No.34556/F,dt.24.11.2017.

4. Now, the State Government have been pleased to decide that three doses of D.A. at the same rate with effect from the same dates released in favour of regular State Government employees vide F.D. Office Memorandums mentioned at Para- 1 & 3 above will also be admissible to those Work Charged employees who are covered under ORSP Rules, 2017 with the same terms and conditions.
5. The term of "Basic Pay" in the revised pay structure means the pay drawn in the prescribed level in the Pay Matrix but does not include any other type of pay like Special Pay.
6. D.A. in accordance with this Memorandum will also be admissible to the Work Charged employees who were in service on 01.01.2016, but have ceased to be in service at the time of sanction of D.A. as per the revised scale of pay.
7. The bills for drawl of D.A. as per revised scale of pay will be submitted to all Treasuries/Special Treasuries/Sub-Treasuries along with the pay bill for the month of **December, 2017** and onwards.
8. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.
9. The payment of arrear Dearness Allowance @2% w.e.f 01.07.2016 and @4% w.e.f. 01.01.2017 shall not be made until further orders
10. The payment of arrear Dearness Allowance @1% i.e. enhancing the existing rate from 4% to 5% w.e.f July, 2017 to November, 2017 will be drawn and disbursed latest by 31.03.2018.
