- In exercise of the powers conferred by sub-sections (1) of section 11 of the Odisha Goods and Services Tax Act, 2017 (Odisha Act 7 of 2017), the State Government, on the recommendations of the Goods and Services Tax Council, do hereby make the following further amendments in the notification of the Government of Odisha in the Finance Department No. 19833-FIN-CT1-TAX-0022-2017, dated the 29th June, 2017, published in the Extraordinary issue No. 1134 of the *Odisha Gazette* bearing S.R.O.No. 296/2017, as amended from time to time, and the last such amendment is in the notification of the Government of Odisha in the Finance Department No. 24924-FIN-CT1-TAX-0043/2017/FIN, dated 27th July, 2018, published in the Extraordinary issue No. 1293 of the *Odisha Gazette* bearing S.R.O. No. 307/2018, namely:-

In the said notification, -

1. In the schedule,

i) for S. No. 43A and the entries relating thereto, the following serial numbers and the entries shall be substituted, namely:-

		Territory, or any public servant, by way of public auction
		by the government, where auction proceeds are used for
		public or charitable cause".

2. This notification shall come into force on the 1st January, 2019.
