Sub: Regulation of expenditure out of the Annual Budget for the year 2020-21-Modification regarding.

Madam/Sir,

I am directed to say that guidelines have been issued vide Finance Department letter No.10324/F, dated 23.03.2020 for regulation of expenditure out of the Annual Budget for the year 2020-21 and the Administrative Departments have been authorized to incur expenditure from 1st April, 2020 on the basis of the provision made in the Annual Budget.

- 2. Global pandemic COVID-19 is growing at an alarming rate and has assumed serious proportions. At this juncture the State Government is taking all possible steps not only to combat the disease but also to prevent it from spreading further. In the process the State is incurring huge expenditure in priority areas to meet COVID related expenses. Under the circumstances, it has become imperative to take adequate measures to prioritize our expenditure within the available resources.
- 3. As per para 10 of Finance Department letter No.10324/F, dated 23.03.2020, expenditure in respect of Central Sector Schemes and Centrally Sponsored Schemes is to be made against availability of Central Assistance only during 2020-21. However, the Administrative Departments were allowed to incur expenditure to the

extent of 50% of the provision made in the Budget Estimate for the year 2020-21 or 50% of the annual allocation made by the concerned line Ministry of Government of India whichever is less, during the first two quarters of the financial year in respect of continuing Central Sector Schemes and Centrally Sponsored Schemes, pending receipt of Central Assistance with concurrence of the Financial Adviser/Assistant Financial Adviser of the Departments. Besides, in case of continuing schemes, the Administrative Departments were also allowed to incur expenditure on the salary component in anticipation of receipt of Central Assistance up to 31.12.2020 without concurrence of Finance Department.

- 4. Taking into consideration the uncertainties in the flow of central assistance from Government of India in respect of Central Sector Schemes and Centrally Sponsored Schemes in the wake of COVID-19, it is now decided that all expenditure relating to Central Sector Schemes and Centrally Sponsored Schemes is to be made only after receipt of central share during 2020-21 from Government of India. No expenditure relating to Central Sector Schemes and Centrally Sponsored Schemes can be made without receipt of central share. The stipulations contained in para 10 (ii), para 12 (ii) (a) and para 13(II) (c) of the Finance Department letter No.10324/F, dated 23.03.2020 stand modified accordingly.
- 5. In case of urgent necessity for release of funds for continuing schemes in anticipation of receipt of central assistance the Administrative Departments shall obtain prior concurrence of the concerned budget & expenditure branch of Finance Department.
- 6. Besides, operation of Cash Management System involving 20 key spending departments (list at Annexure-I) for the year 2020-21 is put on hold until further orders and the enhanced delegation for sanction of funds under Cash Management System indicated in para 12 of the Finance Department letter No.10324/F, dated 23.03.2020 is hereby withdrawn. Accordingly, all Administrative Departments

including the 20 Departments covered under Cash Management System can sanction expenditure up to Rs.1500 lakh at a time under administrative expenditure and transfers from States and Rs.3000 lakhs under Programme Expenditure (State Sector Scheme, Central Sector Scheme and Centrally Sponsored Scheme) as per General limit of sanction mentioned in para 13 (I) of the said letter. The enhanced delegation allowed in Para-13 (II) in case of specified schemes is also withdrawn.

7. Sanction of expenditure exceeding the above limits would require prior concurrence of the concerned budget & expenditure branch of Finance Department in all cases except expenditure under Revenue and Disaster Management (Disaster Management) and Health & Family Welfare Department for which the Administrative Departments are fully empowered to sanction expenditure. Sanction of share capital loan to PSUs/Co-operatives Grant-in-Aid and subsidy to PSUs/Co-operatives shall require prior concurrence of the concerned budget & expenditure branch of Finance Department irrespective of the amount involved.

Administrative Departments are to sanction and release funds for expenditure out of the Annual budget, 2020-21 accordingly.
