S.R.O. No. – In exercise of the powers conferred by section 168A of the Odisha Goods and Services Tax Act, 2017 (Odisha Act 7 of 2017), the State Government, on the recommendations of the Goods and Services Tax Council, do hereby make the following further amendment in the notification of the Government of Odisha in Finance Department No. 18491-FIN-CT1-TAX-0002/2020, dated the 22<sup>nd</sup> June, 2020, published in the Extraordinary issue No. 901 of the Odisha Gazette, dated the 22<sup>nd</sup> June, 2020 bearing S.R.O. No. 138/2020, as amended from time to time, and the last such amendment is made in the notification of the Government of Odisha in the Finance Department No. 25066-FIN-CT1-TAX-0002/2020, dated the 7<sup>th</sup> September, 2020, published in the Extraordinary issue No. 1115 of the Odisha Gazette, dated the 7<sup>th</sup> September, 2020, bearing S.R.O. No. 191/2020, namely:—  
In the said notification, in the first paragraph, in the proviso to clause (i),—

- (i) for the words, figures and letters “29<sup>th</sup> day of November, 2020”, the words, figures and letters “30<sup>th</sup> day of March, 2021” shall be substituted; and
- (ii) for the words, figures and letters “30<sup>th</sup> day of November, 2020”, the words, figures and letters “31<sup>st</sup> day of March, 2021” shall be substituted

2. This notification shall be deemed to have come into force with effect from 1<sup>st</sup> December, 2020.
