No. 305/2017, as amended from time to time, and the last such amendment is made in the notification of the Government of Odisha in the Finance Department No. 10678-FIN-CT1-TAX-0002/2020, dated the 31st March, 2020 published in the Extraordinary issue No.593 of the Odisha Gazette, dated the 31st March, 2020 bearing S.R.O.
