OFFICE MEMORANDUM

Sub: Amendment of Delegation of Financial Power Rule, 1978.

In order to decentralize the decision-making process for expediting execution of various programmes and projects, the financial power of different authorities as prescribed in **Delegation of Financial Power Rule, 1978** have been enhanced from time-to-time. There is still greater need for further enhancement of the powers to avoid delay in taking decisions and providing operational flexibility for execution of various programmes.

- 2. The Delegation of Financial Power Rules, 1978 was comprehensively amended in 2013 and in between eight years have elapsed. In the meantime, the Nominal GSDP and Budget size of the State has increased two-fold and three-fold respectively as compared to 2013-14. It has become imperative to enhance the power of various authorities for timely execution of works. After taking into account the need for effective fiscal management and to avoid delay in execution of various programmes, the State Government have been pleased to amend and revise the various provisions of Delegation of Financial Powers Rules, 1978.
- 3. Rule-10 (d) shall be substituted by the following provisions:

- (1) Subject to Sub-Rule (2), (3) and (4) and the provision of Odisha General Financial Rule governing procurement of goods, engagement of consultant, outsourcing of services and execution of contract, the power of Administrative Department and Heads of Department shall be as follows:

Provided that Administrative Department shall engage consultant for approved project involving high technical requirement within two percentage of the project cost for such services as Architectural Designs, DPR preparations, constructions, supervision consultancy, 3rd party Quality Monitoring and other ancillary services.

Powers of Head of Departments other than the Member, Board of Revenue, Revenue Divisional Commissioner (RDC), Principal Chief Conservator of Forest (PCCF), Director General & Inspector General (DG & IG) of Police and other than those under Works Department, Water Resources Department, Energy Department, Rural Development Department, Panchayati Raj & Drinking Water Department and Housing & Urban Development (H&UD) Department in each case are as follows:-
