OFFICE MEMORANDUM

**Sub:- Fixation of Monetary limit for Khadi Towels**

The monetary limit for purchase of Khadi Towels to be supplied to the Gazetted Officers in the Lok Seva Bhawan was last fixed at the rate of Rs. 150/- (Rupees one hundred fifty) each including all taxes vide FDOM No.9269/F dated 14.03.2012 . Due to rise in the price of Khadi, the current monetary ceiling is considered inadequate.

2. After careful consideration, the State Government have been pleased to enhance the monetary limit from Rs. 150/- to Rs. 400/- (Rupees four hundred) only each including all taxes for purchase of Khadi / Cotton Towels in the Departments of Government to facilitate the supply of the same to the Gazetted Officers in the Lok Seva Bhawan.
3. Towels may be supplied to the Officers at the rate of one each every year. The Departments should also avail of the rebate admissible on Khadi.
4. This order shall take effect from the date of issue.
