No. \_\_\_\_\_ – In exercise of the powers conferred by section 128 of the Odisha Goods and Services Tax Act, 2017 (Odisha Act 7 of 2017), the State Government, on the recommendations of the Goods and Services Tax Council, do hereby make the following further amendment in the notification of the Government of Odisha in the Finance Department No. 40982-FIN-CT1-TAX-0043/2017, dated the 31<sup>st</sup> December, 2018, published in the Extraordinary issue No. 2472 of the Odisha Gazette, dated the 31<sup>st</sup> December, 2018 bearing S.R.O. No 503/2018, as amended from time to time, and the last such amendment is made in the notification of the Government of Odisha in the Finance Department No. 16399-FIN-CT1-TAX-0002/2020, dated the 21<sup>st</sup> June, 2021, published in the Extraordinary issue No.889 of the Odisha Gazette, dated the 21<sup>st</sup> June, 2021, bearing S.R.O. No. 169/2021, namely:–

In the said notification, in the ninth and tenth provisos, for the figures, letters and words “31<sup>st</sup> day of August, 2021”, where ever they occur, the figures, letters and words “30<sup>th</sup> day of November, 2021” shall be substituted.

2. This Notification shall be deemed to have come into force with effect from 29<sup>th</sup> August, 2021.


