S.R.O. No. _____ – In partial modification of the notification of the Government of Odisha in the Finance Department No. 18491-FIN-CT1-TAX-0002/2020, dated the 22nd June, 2020, published in the Extraordinary issue No. 901 of the Odisha Gazette, dated the 22nd June, 2020 bearing S.R.O. No 138/2020 and notification No. 13898-FIN-CT1-TAX-0002/2020, dated the 7th May, 2021, published in the Extraordinary issue No. 727 of the Odisha Gazette, dated the 7th May, 2021 bearing S.R.O. No 129/2021 and in exercise of the powers conferred by section 168A of the Odisha Goods and Services Tax Act, 2017 (Odisha Act 7 of 2017) (hereinafter in this notification referred to as the said Act), the State Government, on the recommendations of the Goods and Services Tax Council, do hereby notify that where a registration has been cancelled under clause (b) or (c) of sub-section (2) of section 29 of the said Act and the time limit for making an application of revocation of cancellation of registration under sub-section (1) of section 30 of the said Act falls during the period from the 1st day of March, 2020 to 31st day of August, 2021, the time limit for making such application shall be extended upto the 30th day of September, 2021.

2. This Notification shall be deemed to have come into force with effect from 29th August, 2021.


