S.R.O. No. _____ – In exercise of the powers conferred by sub-section (1) of section 9 and subsection (5) of section 15 of the Odisha Goods and Services Tax Act, 2017 (Odisha Act 7 of 2017), the State Government, on the recommendations of the Goods and Services Tax Council, do hereby make the following further amendments in the notification of the Government of Odisha in the Finance Department No. 19829-FIN-CT1-TAX-0022/2017, dated the 29th June, 2017, published in the Extraordinary issue No.1133 of the Odisha Gazette, dated the 29th June, 2017 bearing S.R.O. No. 295/2017, as amended from time to time, and the last such amendment is made in the notification of the Government of Odisha in the Finance Department No. 28636-FIN-CT1-TAX-0002/2020, dated the 11th October, 2021 published in the Extraordinary issue No.1650 of the Odisha Gazette, dated the 11th October, 2021 bearing S.R.O. No. 357/2021, namely:-

In the said notification, -

- (a) in Schedule II – 6%, Serial No. 243 and the entries relating thereto shall be omitted;
- (b) in Schedule III – 9%, against Serial No. 452P, in column (3), the words “in respect of Information Technology software”, shall be omitted.

2. This notification shall be deemed to have come into force with effect from 27th October, 2021.
