**OFFICE MEMORANDUM**

**Sub: Extension of the dateline for submission of Annual Life Certificate for the Year 2021 by the Pensioners / Family Pensioners in the Treasuries / Banks**

In continuation to the Finance Department Office Memorandum No-33016 dated 29th November, 2021, the State Government have been pleased to further extend the dateline up to 31<sup>st</sup> January, 2022 for submission of Annual Life Certificate / Non-marriage / Re-marriage Certificate / Non-employment Certificate for the year 2021, as a special case in relaxation of the existing provisions.

2. In case of the demise of the Pensioners /Family Pensioners, during the period under relaxation, the information should be promptly intimated by the spouse/legal heir/ other acquaintances to concerned Pension Disbursing Authority (PDA) for necessary action.

3. The change in employment status, during the extended period, should also be intimated to concern Pension Disbursing Authority (PDA) by the Pensioners. Further, in case of any change of the marital status of the Family Pensioner, during these extended periods, the matter should be intimated to Pension Disbursing Authority (PDA) for necessary action as per the extant Rules.

This shall be applicable to all Pensioners/ Family Pensioners of the State Government and Aided Educational Institutions drawing pension from Treasuries or authorized Banks within the State.
