In supersession to this Department Office Order No. 1114 dtd. 13.01.2022 for the smooth management and proper co-ordination among all the units as well as efficient monitoring and control over all the activities of this Department in a systematic manner, the following arrangement/ work distribution is made among the EICs and EIC-cum-Special Secretaries of DoWR as mentioned against each below:-

- 1. Engineer-in-Chief, Water Resources:** He is the Principal Technical Advisor to the State Government in all matters relating to Water Resources Development in the State. He will look after the construction activities of all major & medium irrigation and Flood control & Drought Management projects, external aided projects as well as all establishments and monitoring of the works, activities of the entire State relating to Water Resources including Mechanical wing. He will supervise Flood, Drainage and Disaster management. He will also look after the Instream Water Storage (ISS) structures. Geographically he will monitor all works but specifically in the Lower Mahanadi Basin and Anandapur Project. He will also look after budget and related activities of Odisha Legislative Assembly (OLA). He will have a lateral linkage with the EIC, P&D and EIC, Procurement. He will coordinate with all the other EICs.
- 2. Engineer-in-chief, Planning & Designs:** He is the Technical Advisor to the State Government so far as planning & designs of the projects under water resources sector of the State. He will review planning, Survey & Investigation, Design & Dam Safety organisations, coordination with OCC Ltd., Central Schemes like JSA etc, Management of CWMI & SDGs and water services. Geographically he will monitor all works, existing and in progress in the Upper Mahanadi Basin (& Tel Sub-Basin) and Ghatkeswar project. He will supervise issues relating to interstate issues. He will have a lateral linkage with the EIC, WR and EIC, Procurement. He will further have linkage with Engineer-in-Chief cum Special Secretary, Scheme & Monitoring, Engineer-in-Chief cum Special Secretary, Inter State Issues and Legal Matters and Engineer-in-Chief cum Special Secretary, Internal Vigilance in the matters of on-going Major and Medium projects and ISS structures.
- 3. Engineer-in-Chief, Procurement:** He is the Technical Advisor to the State Government so far as activities related to Procurement are concerned. He will look after and monitor all procurement operations under the Department. He will have a lateral linkage with the EIC, WR and EIC, P&D. He will also have linkage with Engineer-in-Chief cum Special Secretary, Scheme & Monitoring, Engineer-in-Chief cum Special Secretary, Inter State Issues and Legal Matters and Engineer-in-Chief cum Special Secretary, Internal Vigilance in the matters of on-going Major and Medium projects and ISS structure. Further, he will review & supervise the completed and on-going projects in Indravati & Kolab Basin.
- 4. Engineer-in-Chief –cum-Special Secretary - I, Scheme & Monitoring:** He will be reporting to the Secretary, DoWR on issues relating to various schemes and monitoring of all the activities of the Department. He will also supervise and monitor schemes and programs relating to Ground Water,

Mega Lift, Minor Irrigation & activities related to CAD-PIM in the field. Further, he will review after completed and the on-going projects in Major & Medium Sector and the ISS structures in the Drainage Basin of Subarnarekha, Baitarani and Budhabalanga Basins. To this extent he will have lateral linkage with Engineer-in-Chief, Water Resources, Engineer-in-Chief, Planning & Designs and Engineer-in-Chief, Procurement and also with Engineer-in-Chief cum-Special Secretary-II and Engineer-in-Chief-cum-Special Secretary, Internal Vigilance.

5. **Engineer-in-Chief –cum-Special Secretary - II, Inter State Issues and Legal Matters:** He will be reporting to the Secretary, DoWR on Inter State Issues relating to water resources of the State and legal matters there-of. Further, he will review and supervise the completed and on-going projects in Major & Medium Sector and the ISS structures in the Brahmani Basin. To this extent he will have lateral linkage with Engineer-in-Chief, Water Resources, Engineer-in-Chief, Planning & Designs and Engineer-in-Chief, Procurement and also with Engineer-in-Chief-cum-Special Secretary-I and Engineer-in-Chief-cum-Special Secretary, Internal Vigilance.
6. **Engineer-in-Chief-cum-Special Secretary, Internal Vigilance:** He will be reporting to the Secretary, DoWR on technical issues relating to complaints and grievances on all activities under DoWR through a suitable grievance redressal mechanism. He will also supervise works relating to quality assurance. Further, he will look after the completed and on-going projects in Major & Medium Sector and the ISS structures in the Drainage Basins of Rusikulya, Bahuda, Vansadhara & Nagabali Basin. To this extent he will have lateral linkage with Engineer-in-Chief, Water Resources, Engineer-in-Chief, Planning & Designs and Engineer-in-Chief, Procurement and also with Engineer-in-Chief-cum-Special Secretary-I, Engineer-in-Chief-cum-Special Secretary-II.

All EICs will make field visits and basin wise reviews of the basins assigned including existing projects and the on-going or proposed ones regularly and at least once a month.

On subjects assigned they will hold regular reviews with field units for physical and financial progress.
