OFFICE MEMORANDUM

Sub: Revision of monetary limit for supply of Hot weather and Cold weather liveries to Group-D employees of State Government.

The State Government have revised the monetary limit of Hot weather and Cold weather liveries in favour of State Government Group-D employees vide FDOM. No. 27486 dated 30.09.2021 and FDOM. No. 33167 dated 30.11.2021 respectively. In terms of the above Office Memoranda, the revised provision shall take effect from the date of issue. As, the liveries allowance is being sanctioned with reference to last date of sanction, some Departments are seeking clarification as to whether the revised rate would be applicable in case of group-D employee in whose favour the allowances have already been sanctioned.

It is hereby clarified that, henceforth Hot and Cold weather liveries shall be sanctioned with reference to Financial Year. While, sanctioning the Hot weather liveries, the concerned Head of offices shall ensure that a group-D employee should not avail the allowance more than once in a Financial year. Similarly, in case of Cold Weather liveries, a group-D employee should not avail the allowance more than once in two Financial years.

It is further clarified that the revised rate would also be applicable in case of group-D employee in whose favour the allowances have already been sanctioned and disbursed. The head of the office concerned may sanction the differential amount accordingly. However, it is to be ensured that there should not be any double drawal.
