

SPECIAL SUPPLEMENT TO BUDGET, 2022-23 FOR PANCHAYATI RAJ INSTITUTIONS (PRIs)

FINANCE DEPARTMENT July, 2022

<u>PREFACE</u>

The 5th State Finance Commission constituted under the provisions of Article-243-1 and 243-Y of the Constitution of India, read with Section 3 and 8 of the Odisha Finance Commission (Miscellaneous Provisions) Act, 1993 (Odisha Act 28 of 1993) has submitted its report to the Hon'ble Governor of Odisha in August, 2019 covering all aspects of its mandate. In its recommendations, the Commission has addressed the issue of transfer of resources to the Local Bodies of the State out of the State's Taxes and Consolidated Fund. The Commission has also emphasized on strengthening resource base of the Local Bodies to help them to evolve into responsible units of Local Self-Governance. To synchronize the period of 5th State Finance Commission to the award period of 15th Finance Commission, the scheme of transfer of resources to the Local Bodies has been worked out for six years i.e. 2020-26. The Action Taken on the recommendations of 5th SFC covering a period of six years (i.e. 2020-26) is being laid on the Table of the House in pursuance of Article 243-I(4) and 243-Y(2) of the Constitution.

(i) Devolution: The Commission in its report recommended inter-sedistribution of Devolution amongst the three tiers of Panchayati Raj Institutions. The recommendations are based on population size in each GP and have stipulated devolution amongst the Gram Panchayats, Panchayat Samities and Zilla Parishads of the State in the ratio 70:20:10. But Government has decided the inter se allocation of devolution funds of 5th SFC among the three tiers of PRIs in the order of 60:30:10.

(ii) Assignment of Taxes: The Commission has recommended transfer of fund out of SGST in lieu of Entry Tax for salary and establishment requirements, payment of Honorarium, sitting Fees, T.A and D.A of the elected representatives of Panchayati Raj Institutions. Similarly funds out of Motor Vehicle Tax are earmarked for maintenance / improvement of road infrastructure.

(iii) Grants-in-Aids: Similarly, the Commission has identified some specific services and infrastructure needs of Panchayati Raj Institutions in its report and has recommended Grants-in-Aid to meet the fund requirement for these focus areas in addition to the funds provided under Devolution and Assignment of Taxes. Some of these key areas are provision of drinking water, all weather connectivity, street lights, Rural Haats, maintenance of Primary school buildings, preservation of water bodies, funds for innovative practices, provision of facility at GP Headquarters etc.

As per the decision taken at point 6.12 of the Action Taken Report on the recommendations of the 5th State Finance Commission, a Special Supplement to the Budget document in respect of transfer of funds to Local Bodies on the basis of the recommendations of the Commission is to be presented by the Finance Department in the Legislative Assembly by the end of fiscal year regarding utilisation of grants by the Local Bodies.

The Supplement for Rural Local Bodies (Panchayati Raj Institutions) for the 3rd fiscal year of the 5th SFC award period i.e. year ending by March 2023 has been prepared in compliance to the above decision of Government in the Action Taken Report. The Supplement provides information on Actuals for 2020-21, Revised Estimates for the year 2021-22 & Budget estimates for the year 2022-23.

The Supplement captures the Functional Major Head/Minor Head-wise provision upto Object Head earmarked for transfer to all the three tiers of Rural Local Bodies.
