Sub: Ceiling on consumption of fuel for the official use of Government vehicle / Hired Vehicle....regarding

The State Government had fixed the ceiling on consumption of petrol / diesel per month for the vehicles used by different categories of officers vide para-4 (iii) of FDOM No. 10954 dated 14.03.2001.

- 2. Further, the State Government have also fixed the ceiling of usage of hired vehicle for official use of different categories of officers vide para-3 (vi) of FDOM No 30464 dated 06.09.2019. The aforesaid ceiling on usage is also made applicable for equivalent model of Government vehicles.
- 3. As two different guidelines are prevailing on the subject and creating doubts, the State Government have been pleased to withdraw the ceiling on consumption of petrol / diesel per month for the vehicles used by different categories of officers as fixed vide para-4 (iii) of FDOM No. 10954 dated 14.03.2001.
 - 4. These instructions shall come into effect from the date of issue.
