## Notification The 25<sup>th</sup> November, 2022

S.R.O. No. —In exercise of the powers conferred by section 164 of the Odisha Goods and Services Tax Act, 2017 (Odisha Act 7 of 2017), the State Government, on the recommendations of the Goods and Services Tax Council, do hereby make the following rules further to amend the Odisha Goods and Services Tax Rules, 2017, namely: —

- 1(1) These rules may be called the Odisha Goods and Services Tax (Third Amendment) Rules, 2022.
- (2) Save as otherwise provided in these rules, they shall come into force on the date of their publication in the Odisha Gazette.
- 2. In the Odisha Goods and Services Tax Rules, 2017 (hereinafter referred to as the "said rules"), in **FORM GSTR-9**, under the heading Instructions, in paragraph 7, -
  - (A) for the figures, letters and words "between April, 2022 to September, 2022", the figures, letters and words "of April, 2022 to October, 2022 filed upto 30<sup>th</sup> November, 2022" shall be substituted;
  - (B) in the Table, in second column, -
    - (I) against serial numbers 10 and 11, for the figures and words "April, 2022 to September, 2022", the figures, letters and words "April, 2022 to October, 2022 filed upto 30<sup>th</sup> November, 2022" shall be substituted;
    - (II) against serial number 12, for the figures and words "April 2022 to September 2022", the figures, letters and words "April, 2022 to October, 2022 upto 30<sup>th</sup> November, 2022" shall be substituted; and
    - (III) against serial number 13, for the figures and words "April 2022 to September 2022", the figures, letters and words "April, 2022 to October, 2022 upto 30<sup>th</sup> November, 2022" shall be substituted.
