
In compliance to the order dtd 17.10.2022 passed by Hon'ble Supreme Court of India in the SLP (C) No.3983 of 2022 filed by Subha Narayan Mishra-vrs-State of Odisha and GA&PG Department Letter No.32685/SCS dtd 18.11.2022, the State Government do hereby appoint the following candidate as mentioned below on the basis of the Odisha Civil Services Examination, 2015 conducted by OPSC, Cuttack to Odisha Taxation & Accounts Services (OT&AS), Group-B in Level-10 Cell-1 (₹44,900/-) of pay matrix, ORSP Rules, 2017 in pursuance of sub rule (a) of rule 4 read with sub rule(1) of rule 14 of the Odisha Taxation & Accounts Service Rules, 2011. He shall be on probation for a period of two years as required under sub-rule (1) of Rule 16 of the said rules. 


The services of the officer placed at their disposal may be suitably posted in Block as Accounts Officer under intimation to this Department. The joining report of the said officer may be intimated as well.
