## MODIFICATION TO ACTION TAKEN REPORT ON THE RECOMMENDATIONS OF FIFTH ODISHA STATE FINANCE COMMISSION

## GOVERNMENT OF ODISHA FINANCE DEPARTMENT

Subject: Modification of the provision under para 6.6 of the Action Taken Report (ATR) on the recommendations of Fifth State Finance Commission regarding Assignment of Taxes out of State Goods and Services Tax (SGST) in lieu of Entry Tax for Panchayati Raj Institutions (PRIs) in order to accommodate the salary and other establishment charges of DRDA employees after their merger with the Zilla Parishads.

The Explanatory Memorandum on the Action Taken on the recommendations of the 5<sup>th</sup> State Finance Commission covering a period of six years (i.e 2020-26) was laid in the 3<sup>rd</sup> Session of the 16<sup>th</sup> Odisha Legislative Assembly on 17.2.2020, in pursuance of Article 243-I (4) and 243-Y (2) of the Constitution of India.

- 2. The State Government in PR & DW Department vide Resolution No.10025/PR&DW Dt. 03.06.2022 on "Empowerment of Zilla Parishads by merger of functions and office of District Rural Development Agencies (DRDAs) with Zilla Parishads and abolition of DRDAs in the State of Odisha" have been pleased to merge the functions and Office of DRDAs with the respective Zilla Parishads in districts and abolish the present structure of DRDAs with effect from the date of its publication in the Extraordinary Issue of the Odisha Gazette vide Notification No.1982 Dt. 9.6.2022.
- 3. As per the stipulations of the said Resolution, the salaries and non-salaries expenditure of all the regular employees of Zilla Parishads after merger of DRDAs will be met out of a single Demand Head of Zilla Parishad.
- 4. After merger of DRDA with Zilla Parishad the expenditure under the salary head of Zilla Parishad have increased thereby exceeding the ceiling of normative recommendations of the Commission.
- 5. That, at the time of finalization of the Action Taken Report on the Recommendations of the 5<sup>th</sup> State Finance Commission, the above contingencies—could not be anticipated as there was no scope at that time.

- 6. As per the provisions of para 6.6 of the Action Taken Report "Assignment from SGST in lieu of Entry Tax for Panchayati Raj Institutions and Urban Local Bodies towards Salary and Establishment cost, Sitting Fee, Honorarium, TA&DA are to be in accordance with the normative recommendations of the Commission."
- 7. Now, therefore, after careful consideration of the above facts and circumstances, the para 6.6 of Action Taken Report on the recommendations of the 5<sup>th</sup> State Finance Commission is modified to that extent with the following paras:
  - (i) Assignment from SGST in lieu of Entry Tax for Panchayati Raj Institutions (PRIs) towards Salary and Establishment cost, Sitting Fee, Honorarium, TA&DA are to be on the basis of actual requirement which may exceed the normative recommendations of 5<sup>th</sup> State Finance Commission; and
  - (ii) Assignment from SGST in lieu of Entry Tax for Urban Local Bodies towards Salary and Establishment cost, Sitting Fee and Honorarium are to be in accordance with the normative recommendations of 5<sup>th</sup> State Finance Commission.
