2. The appointment will take effect from the date on which one assumes the office for conducting cases of the Commercial Taxes Organisation.
3. They would be entitled to a monthly retainer fee and daily appearance allowances as per Finance Department Letter No 12245/F dated 10.04.2017. The fees payable will be regulated as per FD G.O. No 39743/F dated 23.07.1987 as revised from time to time and others term and conditions laid down in the said G.O. of Finance Department will also apply.
4. The appointment is terminable at any time with one month's notice from either side or on payment of one month's retainer fee in lieu thereof.
5. They should not advice or appear in cases either in the Orissa High Court or elsewhere against the State Government or any of its Department.
