**Sub: Revision of Conveyance Allowance for employees with benchmark disabilities born on work charged establishment and such employees of Non-Government Colleges and Schools.**

In Finance Department O.M. No. 18455/F dt.12.06.2017, the Conveyance Allowance at the fixed rate of Rs.350/- per month in favour of the blind and physically handicapped and deaf and dumb employees born on the work charged establishment and such employees of Non-Government Colleges and Schools where pay and dearness allowance at Government rates are disbursed directly by Government was allowed at par with that of State Government employees.

2. In the meantime, the Conveyance Allowance in favour of the employees with benchmark disabilities of State Government has been revised at a flat rate of Rs.700/- only per month vide Finance Department O.M. No. 30128/F dt.03.12.2022. The demand for extending the same benefit to the blind and physically handicapped and deaf and dumb employees born on the work charged establishment and such employees of Non-Government Colleges and Schools was under the consideration of Government for some time past.

3. After careful consideration, the State Government have been pleased to decide that the Conveyance Allowance will also be payable at a flat rate of Rs.700/- ( Rupees Seven hundred) only per month to the employees with benchmark disabilities born on the work charged establishment and such employees of Non-Government Colleges and Schools where pay and dearness allowance at Government rates are disbursed directly by Government.

3. All other terms and conditions as laid down in Finance Department O.M. No. 18455/F dt.12.06.2017 and O.M. No. 30128/F dt.03.12.2022 are to be scrupulously followed.

This shall take effect from the 1<sup>st</sup> August 2023.
