Sub: **Delegation of power for sanction of House Building Advance in respect of AIS officers.**

In pursuance to Finance Department Memo No. 3314/F, dt.06.02.1963, House Building Advance in respect of AIS officers has been sanctioned in Finance Department as the funds for sanction of the advances were kept in this Department. In the meantime, global /centralized allotment system of funds for drawal and disbursement of the interest bearing advance in respect of Government employee has been made vide Finance Department letter No.33907/F, dt.03.10.2019.

Now, in order to speed up the process of sanction of house building advance in respect of AIS officers, Government is pleased to delegate the power to the respective Administrative Departments such as General Administration & Public Grievance Department in case of IAS officers, Home Department in case of IPS officers & Forest, Environment and Climate Change Department in case of IFS officers for sanction of house building advance in favour of AIS officers.

This will take effect from the date of issue this memorandum.


