**Sub: Creation, abolition and upgradation of posts under Commercial Taxes and GST, Organisation.**

Madam/Sir,

I am directed to convey the sanction of the Governor for creation , upgradation and abolition of the posts as detailed below under CT&GST Organisation, Odisha.

**a. Creation of posts for new CT&GST Circles**

Balasore-II CT&GST Circle, Bhubaneswar-V CT&GST Circle, Bhubaneswar-VI CT&GST Circle, Cuttack-III CT&GST Circle and Jajpur-II CT&GST Circle have been created after division of the existing Balasore CT&GST Circle, Bhubaneswar-I CT&GST circle, Bhubaneswar-III CT&GST circle, Cuttack-II CT&GST circle and Jajpur CT&GST circle respectively ( statutory notifications for creation of new circle is being issued separately).
