OFFICE MEMORANDUM

Sub: Addendum on the revised procedure for payment of final accumulations under General Provident Fund (GPF) Accounts.

In order to streamline the withdrawal process of final accumulated amount in the General Provident Fund (GPF) account of subscriber, the State Government has revised the procedure of final withdrawal of accumulations in the GPF account of subscriber vide Finance Department O.M. No-19582/F, dated 11.07.2023.

2. As per the revised procedure, the Head of office shall initiate and forward the details of the subscriber retiring or quitting the service to the O/o the Principal Accountant General (A&E), Odisha at least 3 months prior to the date of superannuation. The O/o the Principal Accountant General (A&E), Odisha will process the final GPF application and shall issue the digitally signed electronic authority after proper verification. In case of any discrepancy noticed, the Principal Accountant General (A&E), Odisha shall send back the online application to the Head of Office with objection in IFMS. Then the Head of Office shall comply to the objection raised by the Principal Accountant General (A&E), Odisha and resubmit the application.

3. Now, it has come to the notice that no time limit has been fixed for resubmission of the final GPF application by the Head of Office to the Principal Accountant General (A&E), Odisha. This may cause delay in payment of final GPF amount to the subscriber. Therefore, after careful consideration, the State Government has decided that the concerned Head of Office shall resubmit the online GPF final withdrawal application within 30 days of receipt of the observation from the Principal Accountant General (A&E), Odisha with due compliance.

4. Accordingly, the sentence i.e., "The Head of Office shall comply and the application shall be resubmitted to the Issuing Authority i.e., the Principal Accountant General (A&E), Odisha ." mentioned at Point No-iii of Para-D of Annexure-C of Finance Department OM No.19582/F, dated.11.07.2023 shall be substituted by "The Head of Office shall comply and the application shall be resubmitted to the Issuing Authority i.e., the Principal Accountant General (A&E), Odisha within 30 days of receipt of the observation from the Principal Accountant General (A&E), Odisha ".

5. All other dates and expressions in the Finance Department OM No-19582/F, dated 11.07.2023 shall remain unchanged.

6. This shall come into effect from the date of issue of this OM.
