Sri D Satyabhusan, was appointed to OFS-I(JB) vide Finance Department Notification No 158/F dtd 03.01.2023 and his service was placed at the disposal of the Director, Madhusudan Das Regional Academy of Financial Management(MDRAFM), Bhubaneswar for undergoing induction training. He did not join the training institute for induction training even after 8 months since the issue of offer of appointment .

Para 3 of the OM No-26540/Gen dtd 20.09.2019 provides that, an offer of appointment shall automatically lapse after a period of six months and as per para-4 the revival of such offer of appointment is not admissible after one year from the date of approval of the select list or publication of the select list of the subsequent recruitment whichever is earlier.

In the meantime, subsequent select list of OCS -2021 has already been published. In such circumstances, appointment order of Sri D Satyabhusan cannot be revived as per the limitation prescribed under GA & PG Department OM 26540/Gen ,dated 20.09.2019.

Hence, the offer of appointment made to Sri D Satyabhusan, for appointment to OFS-I(JB) vide Finance Department Notification No 158/F dtd 03.01.2023 is hereby cancelled.




