OFFICE ORDER

Sub: Submission of Annual Life Certificate by the Pensioners / Family Pensioners

Every pensioner / family pensioner, in receipt of monthly pension / family pension from the State Government is required to submit his/her Annual Life Certificate during the month of November for continuation of regular disbursement of his/her monthly pension / family pension in terms of provision of Subsidiary Rule 314(1) of Odisha Treasury Code Volume-I read with Finance Department Notification No. 17024/F, Dated 02/06/2014.

- 2. It has come to the notice of the State Government that there are still a substantial number of pensioners / family pensioners yet to submit their Annual Life Certificate in the Treasuries / Banks as on 30th November, 2023.
- 3. Now taking into consideration the above fact, the State Government has been pleased to further extend the timeline up to **31st December**, **2023** for submission of Annual Life Certificate / Non-marriage / Re-marriage certificate / Non-employment certificate for the year 2023, as a special case, in relaxation of the existing provisions.
- 4. In case of the demise of pensioners / family pensioners, during the period under relaxation, the information should be promptly intimated by the spouse/legal heir/ other acquaintances of the person concerned to the Pension Disbursing Authority (PDA) for necessary action.
- 5. The change in employment status, during the extended period, should also be intimated to the concerned PDA by the Pensioners / family pensioners. Further, in case of any change in the marital status of a family pensioner, during this extended period, the matter should be intimated to the concerned PDA for necessary action as per the extant rules.

This shall be applicable to all pensioners / family pensioners of the State Government and Aided Educational Institutions drawing pension from Treasuries or authorized Banks within the State.
