OFFICE MEMORANDUM

Sub: Grant of per diem allowance for travel outside India on duty / visit / study tour / training / meeting / workshop etc.

Government of India, Ministry of External Affairs (FD Section), New Delhi vides their Order No. Q/FD/695/3/2000., dated 21.09.2010 have prescribed Daily Allowance Rates for the journey of their officers on duty to foreign countries.

There is no such prescribed rate of daily allowance payable to state Govt.employees while proceeding outside India on duty. State Govt. allows daily allowance to its employees while on duty abroad in individual cases at par with employees of Central Govt.

To dispense with the consideration in individual cases, Government after careful consideration, have been pleased to decide that daily allowance will be admissible to its employees while on duty abroad as prescribed in Government of India, Ministry of External Affairs (FD Section), New Delhi vides their Order No. Q/FD/695/3/2000., dated 21.09.2010 as amended from time to time.

This shall be made applicable with immediate effect.
