S.R.O. No. — In exercise of the powers conferred by sub-section (1) of section 9 and sub-section (5) of section 15 of the Odisha Goods and Services Tax Act, 2017 (Odisha Act 7 of 2017), the State Government, on the recommendations of the Goods and Services Tax Council, do hereby make the following further amendment in the notification of the Government of Odisha in the Finance Department No. 19829-FIN-CT1-TAX-0022-2017, dated the 29th June, 2017, published in the Extraordinary issue No. 1133 of the Odisha Gazette, dated the 29th June, 2017 bearing S.R.O. No. 295/2017, as amended from time to time, and the last such amendment is made in the notification of the Government of Odisha in the Finance Department No. 29564-FIN-CT1-TAX-0005-2023, dated the 20th October, 2023, published in the Extraordinary issue No. 2430 of the Odisha Gazette, dated the 20th October, 2023 bearing S.R.O. No. 725/2023, namely:—


In the said notification, in Schedule I – 2.5%, -

- (i) against serial number 165, in column (2), for the entry, the entry “2711 12 00, 2711 13 00, 2711 19 10” shall be substituted; and
- (ii) against serial number 165A, in column (2), for the entry, the entry “2711 12 00, 2711 13 00, 2711 19 10” shall be substituted.

2. This notification shall be deemed to have come into force with effect from the 4th day of January, 2024.




