**RESOLUTION**

No. 4084 /F., dated the 15th February, 2024

PT2-FIN-TRY-ESTT-0026-2016

**Subject: Restructuring of Odisha Treasury Ministerial Service (OTMS) and Odisha Subordinate Financial Service (OSFS) Cadre.**

Consequent upon the increasing functional activities of the Treasuries aimed at delivering prompt and effective service delivery and to ensure effective supervision of field offices, as well as to establish a more streamlined hierarchy within the existing total cadre strength, the restructuring of Odisha Treasury Ministerial Service (OTMS) and Odisha Subordinate Financial Service (OSFS) Cadre was under active consideration of the Government for some time past.

2. Accordingly, it has been decided to restructure the Odisha Treasury Ministerial Service (OTMS) and Odisha Subordinate Financial Service (OSFS) Cadre by way of abolition of some base level posts and creation of same number of posts in the higher level.

3. After such restructuring, the cadre of Odisha Treasury Ministerial Service Cadre and Odisha Subordinate Financial Service shall be as given below:


4. This order supersedes all previous orders issued to this effect.
