Bhubaneswar, dated the 7th March, 2024

No. FIN-CT2-RULE-0001-2023- 6209 /F. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules further to amend the Odisha Subordinate Finance Service (Commercial Tax Branch) Recruitment and Conditions of Service Rules, 1988, namely: -

1. Short title and commencement.- (1) These rules may be called the Odisha Subordinate Finance Service (Commercial Tax Branch) Recruitment and Conditions of Service (Amendment) Rules, 2024.

(2) They shall come into force on the date of their publication in the Odisha Gazette.

2. In the Odisha Subordinate Finance Service (Commercial Tax Branch) Recruitment and Conditions of Service Rules, 1988 (hereinafter referred to as the said rules), in rule (2), for clause(a), the following clause shall be substituted, namely: -

"(a) "Commissioner" means the Commissioner of Commercial Taxes and GST, Odisha or the Chief Commissioner of Commercial Taxes and GST, Odisha."

3. In the said rules, in the APPENDIX appended thereto,-


(a) for serial No. (viii) appearing below the heading "A. PAPER- I - LAW, BOOK KEEPING AND ACCOUNTS", the following shall be substituted, namely: -

"(viii) The Odisha Value Added Tax Act,2004 and rules made thereunder."

(b) after serial No. (viii) appearing below the heading "A. PAPER- I - LAW, BOOK KEEPING AND ACCOUNTS", the following serial No. along with its entries shall be inserted, namely: -

"(ix) The Odisha Goods and Services Tax Act,2017 and rules made thereunder."
