S.R.O. No./2024.— In exercise of the powers conferred by sub-rule (9) of rule 4 of the Odisha Value Added Tax Rules, 2005 and in supersession of all previous notifications issued in this regard, the State Government, do hereby reconstitute the Enforcement Ranges specified in column (2) of the Schedule below, by creation of four new Enforcement or Investigation Units specified in column (4) of that Schedule, comprising the area of jurisdiction or circles mentioned in column (5) thereof against each such range over which an officer shall have to exercise the jurisdiction along with the Enforcement Circle and Enforcement Units of the Ranges noted against each in columns (3) and (4) respectively.

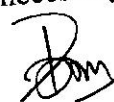
