Sub: Declaration of Assistant Director Savings and Financial Services/ District Financial Service and Savings Officers as District Nodal Officer for monitoring of CSP plus outlets in unbanked Gram Panchayats

Government is hereby pleased to declare Assistant Director Savings and Financial Services/District Financial Services and Savings Officers as District Nodal Officer (DNOs) of respective districts for implementation and monitoring of CSP plus outlets in unbanked Gram Panchayats, in coordination with 6 partner banks (State Bank of India, Punjab National Bank, Union Bank of India, UCO Bank, Bank of India and Bank of Baroda). The DNOs shall undertake following responsibilities in this matter in addition to their existing responsibilities.

1. Regular visit to the CSP Plus outlets and interact with all stakeholders for proper monitoring of the outlets.
2. Coordinate with 6 partner banks and LDM for proper functioning of the CSP plus outlets.
3. Collect and compile all information relating to the CSP plus outlets to apprise Collector and other higher Authorities of Government.
4. Convene District Level Implementation Committee (DLIC) meeting under chairpersonship of CDO-cum-EO of Zilla Parishads.
