And whereas, Ms. Yamini Sarangi, IAS is appointed as Commissioner of Commercial Taxes & GST vice Shri Sanjay Kumar Singh, IAS in the office order of the Government of Odisha in the GA & PG Department No. 24657/AIS.I, dated the 21st August, 2024:

And whereas, certain matters under the Odisha Entertainment Tax Act, 2005 so repealed is saved under sub-sections (2) and (3) of section 174 of the Odisha Goods and Services Tax Act, 2017:

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 3 of the Odisha Entertainment Tax Act, 2006 (Odisha Act 7 of 2006) read with sub-sections (2) and (3) of section 174 of the Odisha Goods and Services Tax Act, 2017 (Odisha Act 7 of 2017) and section 5 of the Odisha General Clauses Act, 1937(Odisha Act 1 of 1937), the State Government do hereby appoint Ms. Yamini Sarangi, IAS, Commissioner of Commercial Taxes & GST, Odisha to be the Commissioner of Entertainment Tax, Odisha, with effect from the date she assumes charge as such, and she shall exercise such powers and discharge such functions as are or may be conferred or imposed by or under the provisions of the Odisha Entertainment Tax Act, 2005.
