OFFICE MEMORANDUM

Sub.: Adoption of austerity measures- Ban on purchase of vehicle

In one-time relaxation of the provision made vide FDOM No 10335/F dated 31.03.2023, the State Government is pleased to allow Administrative Departments to purchase new vehicles for official use of Hon'ble Ministers, except in cases where the existing earmarked vehicle is not more than 1 year old, by adhering to the following conditions.

- (i) Maximum cost of the vehicle shall be Rs. 30.00 Lakh.
- (ii) Mileage shall be as prescribed in FDOM No 10335/F dated 31.03.2023.
- (iii) Where an Hon'ble Minister is in charge of more than one Department, only one new vehicle shall be purchased by one of the Departments concerned as decided by the Hon'ble Minister.
- (iv) Since the purchase of new vehicle is allowed before completion of the life span and condemnation of the vehicle in use, further purchase of new vehicle will not be allowed against this earmarked vehicle after end-of-life span.
- (v) After purchase of the new vehicle, the existing earmarked vehicle should be utilized suitably and shall not be kept idle.

These instructions shall be effective from the date of issue.

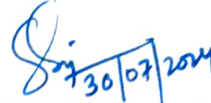

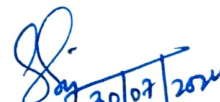
