Subject: Rationalization and recast of sanctioned strength of Common Cadre Auditors under Finance Department.

The proposal for rationalization and recast of sanctioned strength of Common Cadre Auditors under Finance Department with a cadre strength of 510 was under active consideration of the Government.

2) In order to have greater supervisory effect as well as strengthening the Internal Audit system in different Administrative Departments of Government, the Cadre necessitated rationalization and recast of sanctioned strength in the Internal Audit wings of the concerned Departments and increase of posts at the Supervisory level. 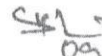
