NOTIFICATION

Bhubaneswar, the 7th July, 2000.

No.CS-(II)-4/2000. 28698 /F., In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Orissa is pleased to make the following rules further to amend the Orissa Service Code, namely :-

1. (1) These rules may be called the Orissa Service Code (Amendment) Rules, 2000.

(2) They shall be deemed to have come into force on the first day of January, 1996.

2. In the Orissa Service Code, for the first part of Appendix-9, the following part shall be substituted, namely :-

RATES OF CONTRIBUTION PAYABLE DURING FOREIGN SERVICE.

I. Rates of monthly contribution for pension payable during active foreign service shall be as follows :-

Year of service. Rates of monthly contribution expressed as percentage of the maximum monthly pay of the post in the officiating substantive grade, as the case may be, held by the officer at the time of proceeding on foreign service.
