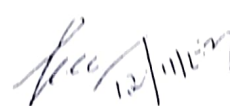

Sub : **Accommodation for Freedom Fighters of the State**

I am directed to say that the State Freedom Fighters who are getting State Freedom Fighters Pension or Central Freedom Fighters' pension are entitled to avail the accommodation in Orissa Bhawan/ Orissa Niwas at New Delhi, Utkal Bhawan at Kolkata, Circuit Houses, Inspection Bungalows, Rest Sheds and such accommodations both inside and outside the State subject to availability of accommodation and observation of other rules of reservation.

The charges on their stay in such accommodations under the control of various Departments of the State are equal to the charges payable by sitting MLAs. The Freedom Fighters can avail the aforesaid benefit on production of Freedom Fighters Identity Card issued by the appropriate authority.
