OFFICE MEMORANDUM

*Bhubaneswar, the 18th May 1987*

Consequent upon the revision in scales of pay of State Government Employees the rates of House Rent Allowance have been revised with effect from The 1st January 1986 in Finance Department Office Memorandum No. 9/F., dated the 1st January 1986. As per para. 3(d) of the said Office Memorandum, "Pay" means the pay as defined in Rule 33 of Orissa Service Code. In view of this, Government Employees who are continuing in the pre-revised scales of pay are being granted House Rent Allowance on the pay drawn in the pre-revised scale which prevailed prior to the 1st January 1985. The question of inclusion of Dearness Allowance and Additional Dearness Allowance to the pre-revised scales of pay of such employees for the purpose of granting House Rent allowance was under consideration of the Government for some-time past. Government, after careful consideration, have been pleased to decide that pay for the purpose of granting House Rent Allowance to such employees shall include pre-revised scales of pay, Dearness Allowance and Additional Dearness Allowance admissible as on the 31st December 1984. As such, the following provision shall be inserted under para. 3(d) of Finance Department Office Memorandum No. 9/F., dated the 1st January 1986.

"In this case of persons who continue to draw pay in the scales of pay which prevailed prior to the 1st January 1985 it will include, in addition to pay in the pre-revised scales, Dearness Allowance and Additional Dearness Allowance admissible to that pay as on the 31st December 1984".

This will be given effect from the 1st January 1986.
