SUBJECT:- GRANT OF HOUSE RENT ALLOWANCE - CLARIFICATION
THEREOF.

The undersigned is directed to invite a reference to Finance Department Memo No. 16875-F dated 20.4.88 wherein it has been stipulated that

"If husband and wife have been posted at the same headquarters and have not been provided with Government accommodation one of them will get house rent allowance and similarly if they are residing in their own house, one of them will get house rent allowance".

Doubts have arisen in some quarters as to whether house rent allowance shall be admissible to a State Government employee, whose husband/wife posted at the same headquarters is a Central Government employee or an employee of Reserve Bank of India, Nationalised Banks or Regional Rural Banks or Co-operative Organisations of State Government or an autonomous body or local body or Undertakings and Companies owned, controlled or aided by Central/State Government and is in receipt of house rent allowance of provided with accommodation from the organisation. After careful consideration it has been decided that house rent allowance will not be admissible to a State Government employee whose husband/wife is in receipt of house rent allowance or provided with accommodation by the Central Government or any of the organisations as mentioned above.

It is also further decided that the Government employees shall, in addition to the certificate prescribed in paragraph 3(m) of Finance Department O.M. No. 9-CS-IV-105/85-F., dated 1.1.86, furnish a certificate in the enclosed form for grant of house rent allowance.
