OFFICE MEMORANDUM

Bhubaneswar, the 14th July 1987

SUBJECT—Payment of House Rent Allowance in favour of Government Employees

Para. 2 of Finance Department Office order No. 33076/F., dated the 9th June 1986 read with Finance Department Corrigendum No. 33526/F., dated the 13th June 1986 enjoins that house rent allowance shall be admissible to Government employees who surrender Government quarters after occupying it to move to their own houses within six months prior to the date of their retirement. This concession however is not admissible at present to other categories of Government employees who are in occupation of Government accommodation and wish to surrender it to move into their own houses.

The above question has since been reviewed. To encourage Government employees, who are presently occupying Government accommodation, to move to their own houses and thereby release Government accommodation for others who are in the waiting list for years, the Government have been pleased to decide as follows:

- (a) "House Rent Allowance shall be admissible to a Government employee who refuses Government accommodation when offered or surrenders the same after occupying it to move to his own house irrespective of the date of his retirement".

Government employees who have refused or surrendered Government accommodation prior to issue of this order shall also be eligible for the said House Rent Allowance from the date of issue of this O. M.

- (b) The existing provision in Para. 3(e) of Finance Department Office Memorandum No. 9/F., dated the 1st January 1986 which provides that the Government employees debarred from allotment of Government accommodation due to un-authorised subletting or breach of allotment rules will not be eligible for house rent allowance, shall continue to exist.

This order shall come into force with effect from the date of issue of the order.
