Sub: Revision in the rate of House Rent Allowance and grant of compensation in lieu of rent free accommodation.

In continuation to Finance Department O.M. No.55376/F dated 26.12.2008 on the above cited subject, the Government after careful consideration of the representation of different service Organisations/ Associations, have been pleased to decide that the State Government employees who are entitled to the facility of rent free accommodation and who have not been provided with such accommodation shall be entitled to H.R.A towards compensation in lieu of rent free accommodation as under :-

- (i) the lowest amount charged as licence fee for the entitled type of accommodation; and
- (ii) House Rent Allowance admissible to corresponding employees in that classified city/unclassified place in terms of F.D.O.M. No. 55376/F dated 26.12.2008.

This order shall come into force with effect from 01.12.2010 and all other terms and conditions stipulated in the above referred O.M. (No.55376/F dated 26.12.2008) stand unaltered.
